

SUBJECT: CNP - National Weather Service Heat Advisory Has EXPIRED

NOTICE DATE: August 12, 2015

NOTICE TYPE: Final

SHORT DESCRIPTION: National Weather Service Heat Advisory - **Expired.**

INTENDED AUDIENCE: Retail Electric Providers

LONG DESCRIPTION: The National Weather Service Heat Advisory that was in effect through Wednesday, August 12, 2015 until 9:00 PM has expired for the CenterPoint Energy Service Territory. CenterPoint Energy will resume Disconnections of Service for Non-Payment (DNP) on **Monday, August 17, 2015** if no other heat advisories are put into effect before then.

SUBJECT: CNP - National Weather Service Heat Advisory EXTENDED - Suspension of DNP Orders

NOTICE DATE: August 12, 2015

NOTICE TYPE: Informational (Follow-Up)

SHORT DESCRIPTION: National Weather Service Heat Advisory – **Extended**

INTENDED AUDIENCE: Retail Electric Providers

LONG DESCRIPTION: The National Weather Service extended the Heat Advisory at 3:35 AM CDT on Wednesday, August 12, 2015 for the CenterPoint Energy Service Territory which requires the continuation of the Extreme Weather Moratorium on Disconnects. The Heat Advisory is in effect until 9:00 PM CDT on Wednesday, August 12, 2015.

Per market rules, DNP orders will be suspended through **Friday, August 14, 2015**, meaning that **Monday, August 17, 2015** is the earliest day that CenterPoint Energy would be able to execute new DNP orders from Competitive Retailers, if the Heat Advisory expires.

CenterPoint Energy's Process for Extreme Weather Moratoriums on Disconnects:

- DNP orders that were previously submitted and are currently in our system will be voided / turned down with a Weather Advisory code of "W" for V001 – Complete Unexecutable on the specific "Date Wanted" that is within the Weather Moratorium window

- New “Same Day” DNP orders that are submitted during the existing Weather Moratorium will be rejected with a Weather Advisory code of “W” for A13 – Weather Advisory
- New DNP orders may be submitted for requested future “Date Wanted” dates and will be accepted by our system. However, these orders may be subsequently voided / turned down if the “Date Wanted” falls within a Weather Moratorium window.
